The "Model" (identified in the previous section), in the interest of gaining valuable modeling experience and in exchange for photographic images, does hereby irrevocably authorize the "Photographer" (identified in the previous section), and those acting with Photographer's permission, to use the photographic images taken by Photographer on the date (shown above) and derivative works based thereupon (collectively hereafter identified as the "Photos") for all lawful purposes subject to the terms and conditions described herein.

The Model agrees that the aforementioned exchange is for the Photos provided to the Model by Photographer in the following methods:

1. Within 15 days of the Date, an electronic gallery of original, un-retouched Photos shall be made available to the Model for evaluation and comment. The gallery will be posted to the LightWurx Media website (URL in the header) for review. The Model may make suggestions on images and express comments on which images should receive post-production processing, but the Photographer reserves the right to select which images will receive post-production retouch processing. The Photographer also reserves the right to decide the quantity of the Photos that will receive retouch processing (typically, no more than ten depending on the shoot duration).
2. The retouched Photos shall be released to the Model in an electronic format within 15 business days after the un-retouched gallery mentioned in the previous paragraph has been released. The format of the release shall be in the JPEG file format and in "print ready" condition. Reduced-resolution versions suitable for uploading to whatever website the Model wishes shall also be in the same release. The Model may select up to 5 images for post-processing with the understanding that any amount over this will constitute a fee (to be negotiated separately).

The Model agrees that the Photos will be used for purposes related to promoting their personal modeling business or acting career, including but not limited to personal advertising, portfolios, composite cards, exhibitions, contests, and promotional internet websites, bio documentation and resumes. The Model will not sell or release publication rights of the Photos, nor use or release them for any commercially related purpose without Photographer's prior consent in writing. The LightWurx Media logo and accompanying copyright information may not be removed from the images or the accompanying embedded data. Photo manipulation includes cropping or applying text that suggests the image was photographed for any other purpose than the previously mentioned personal promotional use. The Model shall be held accountable for controlling the distribution of images. In any use of the Photos for promotion, credit must be given to the Photographer (this includes completing photographer's links on sites like One Model Place, Model Mayhem and similar portfolio sites). Likewise, the Model authorizes Photographer (the exclusive copyright holder) to use the Photos for purposes related to the promotion of Photographer's business, including but not limited to advertising, portfolios, composite cards, exhibitions, contests, and promotional internet websites, but does not authorize Photographer to sell publication rights for any or all of the Photos without prior written consent. The Photographer must credit the Model (this includes completing model's links on sites like One Model Place and Model Mayhem, as well as on the LightWurx Media website) in his or her choice of legal name or stage name identified above.

The Model hereby releases and agrees to hold harmless Photographer and those acting under his permission, from any liability by virtue of blurring, distortion, alteration, optical illusion, or use in composite form whether intentional or otherwise, that may occur or be produced in the taking of the pictures, or in any processing tending toward the completion of the finished product, unless it can be clearly shown that the foregoing was maliciously caused, and produced, and published solely for the purpose of subjecting the Model to conspicuous ridicule, scandal, reproach, scorn, and indignity.

The Model hereby affirms that all poses, positions and situations enacted in the Photos covered in this release were entered into without force, coercion, or threat whatsoever, and were posed freely by Model with Model's full consent. Model further agrees to hold blameless and free of all accusation of such force or coercion Photographer, his legal representatives, assigns, and those acting under his permission.

The Model is fully able to contract in his/her own name without breach of any prior agreement or applicable law, including but not limited to prior agreements with modeling and talent agencies. Model also acknowledges that they are at least 18 years of age and may legally endorse this contract with their signature. The Model has read the foregoing prior to its execution and is fully familiar with and agrees to the contents thereof. The Model acknowledges a copy of this form (photocopy, FAX, digital copy) is as valid as the original.
